**PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE USING THIS SITE OR OUR APP**

### **1. What's in these terms?**

These terms tell you the rules for using our website [www.ascensio.co.uk](http://www.ascensio.co.uk) or accessing any of our courses, including the GLR Programme, via Microsoft Teams or otherwise (**our Site**).

### **2. Who we are and how to contact us**

Our Site is operated by Ascensio Limited ("**We**"). We are registered in England and Wales under company number 08047199 and have our registered office at 1 Brassey Road, Shrewsbury, SY3 7FA. Our VAT number is [VAT NUMBER].

### **3. By using our Site you accept these terms**

By using our Site, you confirm that you accept these terms of use and that you agree to comply with them.

If you do not agree to these terms, you must not use our Site.

You are also responsible for ensuring that all persons who access our Site through your internet connection are aware of these terms of use and other applicable terms and conditions, and that they comply with them.

We recommend that you print a copy of these terms for future reference.

### **4. There are other terms that may apply to you**

These terms of use refer to the following additional terms, which also apply to your use of our Site:

We may update and change our Site from time to time to reflect changes to our services (including our courses), our users' needs and our business priorities.

### **7. We may suspend or withdraw our website**

Our website is made available free of charge.

We do not guarantee that our Site, or any content on it, will always be available or be uninterrupted. We may suspend or withdraw or restrict the availability of all or any part of our website for business and operational reasons. We will try to give you reasonable notice of any suspension or withdrawal.

#### **8. We may transfer this agreement to someone else**

We may transfer our rights and obligations under these terms to another organisation. We will always tell you in writing if this happens and we will ensure that the transfer will not affect your rights under the contract.

#### **9. Our Site is only for users in the UK.**

Our Site is directed at people residing in the United Kingdom. We do not represent that content available on or through our Site is appropriate for use or available in other locations.

#### **10. You must keep your account details safe**

If you choose, or you are provided with, a user identification code, password or any other piece of information as part of our security procedures, you must treat such information as confidential. You must not disclose it to any third party.

We have the right to disable any user identification code or password, whether chosen by you or allocated by us, at any time, if in our reasonable opinion you have failed to comply with any of the provisions of these terms of use.

## **17. How we may use your personal information**

We will only use your personal information as set out in our Privacy Policy.

## **18. Uploading content to our Site**

Whenever you make use of a feature that allows you to upload content to our Site or to make contact with other users of our Site, either directly or via Microsoft Teams, you must comply with the content standards set out in our [Acceptable Use Policy](#).

You warrant that any such contribution does comply with those standards, and you will be liable to us and indemnify us for any breach of that warranty. This means you will be responsible for any loss or damage we suffer as a result of your breach of warranty.

Any content you upload to our Site, especially via Microsoft Teams, will be considered non-confidential and non-proprietary. You retain all of your ownership rights in your content, but you are required to grant us a limited licence to use, store and copy that content and to distribute and make it available to third parties. The rights you license to us are described in the section of this document entitled "Rights you are giving us to use material you upload".

We also have the right to disclose your identity to any third party who is claiming that any content posted or uploaded by you to our Site constitutes a violation of their intellectual property rights, or of their right to privacy.

We have the right to remove any posting you make on our Site if, in our opinion, your post does not comply with the content standards set out in our [Acceptable Use Policy](#).

You are solely responsible for securing and backing up your content.

We do not store terrorist content.

## **19. We are not responsible for viruses and you must not introduce them**

We do not guarantee that our Site will be secure or free from bugs or viruses.

You are responsible for configuring your information technology, computer programmes and platform to access our Site. You should use your own virus protection software.

You must not misuse our Site by knowingly introducing viruses, trojans, worms, logic bombs or other material that is malicious or technologically harmful. You must not attempt to gain unauthorised access to our Site, the servers on which our Site is stored or any server, computer or database connected to our Site. You must not attack our Site via a denial-of-service attack or a distributed denial-of service attack. By breaching this provision, you would commit a criminal offence under the Computer Misuse Act 1990. We will report any such breach to the relevant law enforcement authorities, and we will co-operate with those authorities by disclosing your identity to them. In the event of such a breach, your right to use our Site will cease immediately.

## **21. Which country's laws apply to any disputes?**

You and we both agree that the courts of England and Wales will have exclusive jurisdiction except that if you are a resident of Northern Ireland you may also bring proceedings in Northern Ireland, and if you are resident of Scotland, you may also bring proceedings in Scotland.

If you are a business, these terms of use, their subject matter and their formation (and any non-contractual disputes or claims) are governed by English law. We both agree to the exclusive jurisdiction of the courts of England and Wales.
